He is a graduate of the Academy of Humanities in Pułtusk, Department of Political Sciences - Political Science / Transport Policy of the European Union - part-time second cycle master's degree studies and of the University of Agriculture in Kraków, where he completed his post-graduate studies in Hunting Economy and Wildlife Protection and undergraduate studies at the School of Management and Marketing in Leszno, majoring in Management and specializing in Marketing and Management. He is also a graduate of the Meat Industry Technical High School in Krotoszyn, he has the title of a technician in food technology, specializing in meat processing.

In respect of the restructuring and operational improvement at PKM DUDA, he was responsible for establishing the principles of remuneration in the trade and production departments of PKM DUDA and for development and communication of clear rules for calculation of components as the remuneration variables, optimization of production processes in the slaughtering and cutting area, as well as in the processing sector. From 1990 to 1992, he worked at PPH "RECKO" Sp. z o.o. as a livestock purchaser and slaughter house foreman and then the Chief Technologist.

In 1992 and 1993, in Zakładzie Wyrobów Różnych "WERMET" in Rawicz, he held the position of the slaughtering and cutting processes manager.

From 1993 to 1996, he was employed at Handel i Przetwórstwo Rolno-Spożywcze Marek Duda as a foreman of the slaughtering shift.

From 1997 to 1999, he worked at Zakłady Mięsne MBM DUDA s.c. as a trade and production manager, and then – from 12/09/1998 – as the trade and production director.

From December 2003 to December 2005, he was a Member of the Management Board for Trade and Production at Zakłady Mięsne DUDA Sp. z o.o., transformed into Zakłady Mięsne DUDA S.A., and then into Polski Koncern Mięsny DUDA S.A.

Since 1 January 2006, he has been the Vice President of the Management Board of GOBARTO S.A.
